This obligation shall be understood jointly and severally between each party named in this confidentiality agreement;

6) Any dispute under this agreement shall be subject to <u>Swiss law</u>. The parties hereby elect the <u>Court of Chiasso, Pretura di Mendrisio</u> <u>Sud</u>.
